BLANCH: This product is blanched

FREEZING TECHNIQUE: Individual quick frozen (IQF)

APPEARANCE Whole kernels, clean, free flowing, no icy, no clumps, typical

for varieties to be used. The hoar frost is no a defect. Kernels not calibrated, size resulting from the structure of the corn cob,

properly cut.

COLOR: Typical for varieties to be used, not uniform white and yellow.

TASTE AND ODOR: Typical for the product, free off odors and tastes, a little

mealiness to be allowed.

WHOLESOMENESS: kernels to be sound, practically free of damages caused by

diseases or/and pests, the kernels scalded and moldy to be not

allowed.

CONSYSTENCY: When frozen - hard, the skin is quite hard

Defrosted - typical for the product, weakened by the blanching

process.
