INGREDIENTS: Apples, ascorbic acid (1.5%), salt (0.5-1%), citric acid (0.5%)

CUT AND SIZE: 3/8" X 3/8" X 3/8" (size tolerance 10%)

BLANCH: This product is not blanched

FREEZING TECHNIQUE: Individual quick frozen (IQF)

ORGANOLEPTIC STANDARDS The product possesses a good characteristic normal odour, flavor crispiness and aroma, typical of the Granny Smith variety.

COLOR: Reasonably uniform bright color, characteristic of the variety Granny Smith. Free from discoloration, internal and external.

MAJOR DEFECTS: No tolerance for stones, glass, plastic, metal, hair, wood.

MINOR DEFECT: There shall be no more than 5% by weight of defects per sample.
 Defects include:

- Peel: 1/8" circumference or larger.
- Bruise: Light bruise- must be larger than 1/8" circumference. Dark bruise- all defects count.
- Blossom end: All defects count.
- Stem end: All defects count.
- Carpel: All defects count larger than 1/8".
