Each 9 oz. portion pack shall consist of 70% (+/-5%), by weight, fully cleaned squid rings cut to ring width of 5/8" and 30% (+/-5%), by weight, fully cleaned, whole tentacle sections. Rings shall be cut from 4-6 inch fully cleaned tubes.

7. PACKAGING AND LABELING REQUIREMENTS

A. Product shall be packed inside approximately 3.0 mil heat sealed, clear sleeve and frozen. Please see photo below showing 8.5" x 5" sealed bag dimensions.



B. 25 individual 9 oz portion packs shall be placed in a labeled, oyster white, staple free 14.06 lb, poly-bag lined Master case with a minimum bursting strength of 200#.C. Case labels and printing shall conform to standards set forth by PanaPesca Quality Assurance.

D. Production date code system shall consist of a five digit code. The first and fourth digits shall identify the month, the second and third digits shall represent the day, and the fifth digit will represent the year. Examples are:
