DESCRIPTION

Salted Butter Pots are prepared by churning pasteurized cream to obtain a product with not less than 80% butter fat. The product is whipped with the addition of compressed nitrogen. They are packaged in single serve pots. It conforms to the requirements for Canada #1 grade and meets the requirements of the Food and Drugs Act and Regulations. This product is processed in a HACCP certified facility (CFIA June 2003) in accordance with Good Manufacturing Practices. Dairy Plant Registration Number is 524 with SFCR license number 4NLP9FDV.

Freshly churned butter maybe frozen for up to 365 days (-10°C, 12°F max). Once the butter is thawed it has a shelf life of 150 days at refrigerated temperatures of 4°C (39.2°F).

A polystyrene cup with polyethylene coated paper seal. Packaged 600 x 4.5 g in an RSC box

SHIPPING & STORAGE CONDITIONS

The product is to be shipped and stored at or below refrigerated temperature of 4°C (39.2°F). The quality of the product is maintained with minimum exposure to light, heat and air.
